History and Mission

LAIC+OCLC is a legal incubator that supports attorneys as they establish and grow community-based solo practices. Applications are open to attorneys licensed in California. LAIC was formed in 2014 with seed funds from the California State Bar's Access to Justice Commission to provide affordable legal services to underserved communities. Partners include Public Counsel, Bet Tzedek, Neighborhood Legal Services and Legal Aid Foundation of Los Angeles, as well as the LA Law Library.

OCLC began as a collaborative effort between four Orange County non-profit legal services firms: Community Legal Aid So Cal, Veteran's Legal Institute, Public Law Center, and the Elder Law and Disability Rights Center (ELDR). In 2023, LAIC and OCLC officially combined, under the fiscal sponsorship of ELDR.

Program Benefits

LAIC+OCLC's boot camp and year-long curriculum includes workshops on legal skills, marketing and business development, work-life balance, and law practice management. Participants meet weekly, and the program director is on-call for check-ins and coaching. They are introduced to mentors, and receive complimentary subscriptions to law practice management software, legal research and educational tools. They gain experience and supervision while meeting their pro bono requirements (100 hours min.) with legal services organizations.

A Supportive Community that Fosters Leadership and Service

LAIC+OCLC strives to be a supportive community for diverse attorneys to develop unique professional voices and leadership skills. To date, 115 attorneys launched their practices in the program, representing dozens of practices areas and 31 language fluencies. They have volunteered over 12,500 pro bono hours to people who would otherwise have no legal help, amounting to a value of well over \$3 million in legal services to help the greater community.

 - How LAIC's 100-hour pro-bono volunteer service requirement will contribute to your solo practice's success.

APPLICATION FOR 2026 PROGRAM YEAR (2/1/26-1/31/27)

Los Angeles Incubator Consortium and Orange County Legal Consortium (LAIC+OCLC) help solo lawyers develop sustainable law practices in underserved communities to increase access to the laws and justice. During the program year, participants receive subsidized workspace and legal resources, mentoring, trainings on law practice management, and guidance on marketing, business, and client development.

Participants commit to volunteer at least 100 hours of pro bono service, in which they receive substantive training in practice areas while performing work in a range of opportunities developed by civil legal aid agencies and community partners, including Bet Tzedek, Legal Aid Foundation of Los Angeles, Community Legal Aid So Cal, Elder Law and Disability Rights Center, Neighborhood Legal Services, Public Counsel, Veteran's Legal Institute and the Los Angeles Law Library.

LAIC+OCLC is open to attorneys with active bar licenses in California (or attorneys with out-of-state licenses who limit themselves to federal practices, e.g., immigration). If selected, participants must commit to starting their law practice no later than Feb. 1, 2026. The cost is \$4,800 if paid in monthly installments (\$400/month for 12 mos.) or \$4,400 if paid before 2/1/25 (one month free).
